

PET VISIT CONTRACT

Parties

The parties to this contract and agreement are:

Both parties hereby agree to utilise these addresses for all legal correspondence and matters.

Service Provision

The Owner hereby engages the Visitor to provide pet care services as delineated in this contract, as well as in the Pet Information Sheet and the Veterinary Release Form. Services detailed on the website www.edspets.co.uk under services and rates.

Compensation

The Visitor shall receive compensation in the total amount of:	£ per visit

Additional charges may be levied for food, supplies, transportation, or veterinary emergencies, subject to presentation of appropriate receipts.

Contract Term

The duration of this Pet Visitor Contract may be extended upon the Owner’s request for additional Pet Visits, provided the Visitor consents, until such time as either party elects to terminate this Agreement. In such event, a subsequent agreement may be drafted.

The Owner bears responsibility for confirming their return and availability to resume care of the premises and pet(s) on or before the final day of the contractual term; failure to do so will entitle the Visitor to perform further visits in the interest of the pet(s)’ welfare.

Any supplementary visits or responsibilities shall be compensated at the following rate:	£ per visit

Cancellation

Either party may terminate this Agreement with a minimum of forty-eight (48) hours’ notice. Cancellations made by the Owner within forty-eight (48) hours of the scheduled visit, except in cases of emergency, shall incur a fee of fifty percent (50%).

If the Visitor is compelled to cancel within forty-eight (48) hours due to emergency or illness, a substitute may be designated with the Owner's prior approval. If such arrangement proves unsatisfactory, any previously paid fee will be refunded in full.

Pet Behavior

Should any pet exhibit aggressive or dangerous behavior, the Visitor is authorised to:

- Coordinate with the pet's Guardian (as designated by the Owner) to assume responsibility for the pet until the Owner's return;
- Arrange for the pet to be placed in a kennel, animal care facility, or with a boarder at the Owner's expense should the Guardian be unable or unwilling to do so.

Liability

- The Visitor shall not be held liable for property damage, pet loss, or mishaps if other individuals possess access to the property.
- The Visitor shall not be held liable for incidents involving pets with unsupervised outdoor access.
- The Owner shall be responsible for all medical expenses and damages caused by their pet.
- The Visitor is released from any liability related to pet transportation, medical intervention, or related expenditures.

Emergencies

- If the Owner cannot be reached, the Visitor is authorised to:
- Transport the pet to a veterinarian or emergency clinic as specified by the Owner, or, if no designation exists, at the Visitor's discretion;
- Request on-site veterinary treatment for the pet.

Security

The Visitor shall maintain the confidentiality of all keys, codes, and personal information and shall return them to the Owner upon termination of this contract.

Entire Agreement

This contract, together with the Pet Information Sheet and the Veterinary Release Form, constitutes the entire agreement between the parties. Any modifications must be documented in writing and signed by both parties.

Assignment

No party shall assign its rights or delegate its obligations under this Pet Visit Contract without the prior written consent of the other party, except in circumstances where inclement weather or a bona fide emergency prevents the Sitter from fulfilling their duties. In such cases, the pet's Guardian may be called upon to assume care of the pet(s).General
